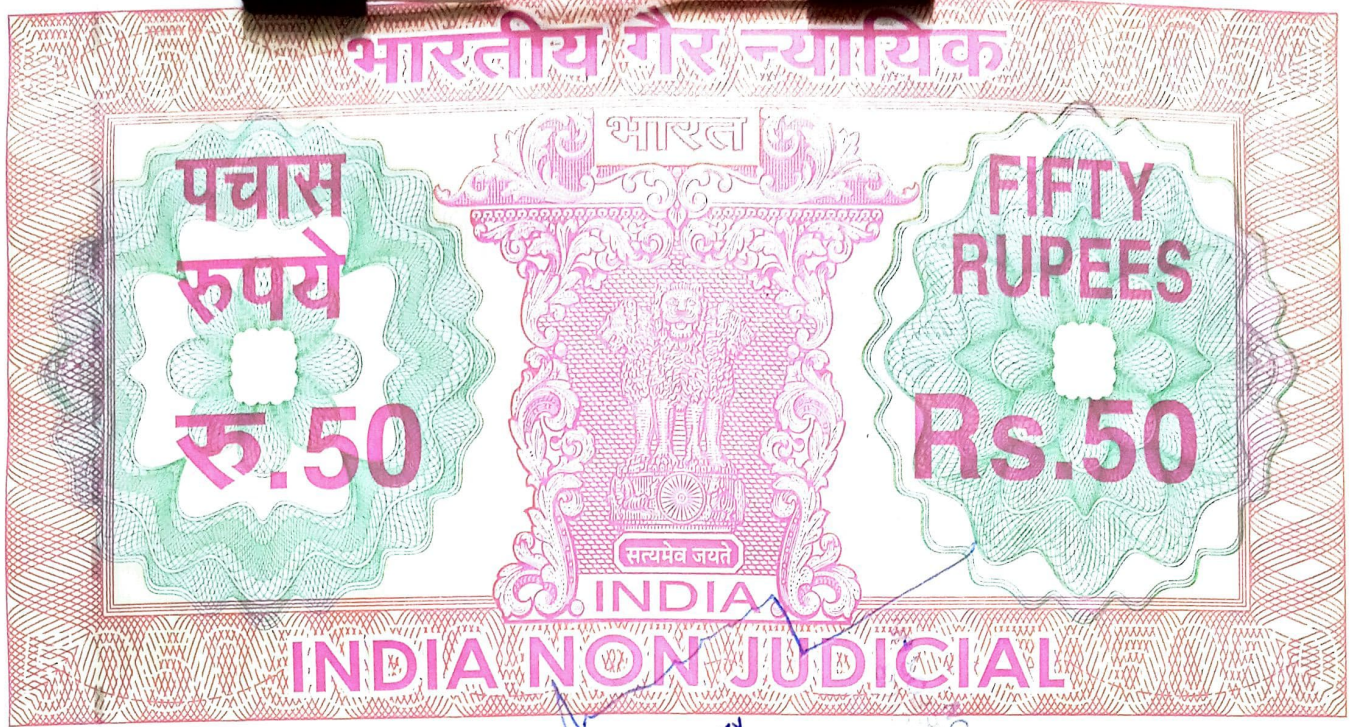

RCUN-NER and Goalpara College have agreed to the following:

1. **Purpose:** It is the MoU for the cooperating parties to give on the development of the college in the field of education, Science Culture and Environment.

2. Areas of Cooperation :

- a. Goalpara College has agreed to assist RCUN-NER for promoting UN/UNESCO programmes in the college jointly.
- b. Goalpara College will provide execute the activities /programmes of RCUN-NCR while RCUN-NER will support the ~~NC~~ to execute it.
- c. Goalpara College will provide RCUN-NER its Conference Hall/Manpower etc. for the UN/UNESCO programmes to held in the college.
- d. RCUN-NER will set up a UN reading library at Goalpara College while Goalpara College shall provide a space exclusively for it and will send its feedbacks reports to RCUN-NER quarterly.
- e. Goalpara College may nominate a person from its college for the state/National/International conferances of UN/UNESCO as part of deligations of RCUN-NER.
- f. Goalpara College and RCUN-NER shall promote the activities of International Youth Hostel for the welfare of the faculty/Staff/Students of the college.
- g. Goalpara College may facilate and academic enrollment in the college for the benefit of the inmates /children of the senior officials of RCUN-NER to acquire a better quality education if seat will be available.
- h. Goalpara College and RCUN-NER will support and cooperate to each other in undertaking any Study/Research releated to sustainable development activities in Assam.

General Provision:

The MoU shall be effective upon signature by both the parties for a period of 24 months from the date of signature. The MoU may be extended beyond the period upon mutual consent of the parties.

The MoU may be terminated by RCUN-NER or by Goalpara College upon written notice to the other party and shall terminate 30 days after receipt such notice from the parties.
